Show one-Junior Handling/Conformation: Judging at 10:30 am or after obedience is done. Gary Dunlop – AKC Judge

Entries taken day of 7:00am-10:30 am

Show two-Junior Handling/Conformation: Judging at 2:00 pm or after first show is done. Margi Floyd – Provisional Breeder Judge

Entries taken day of 1:00pm – 2:00pm

Obedience: Judging begins 8:00 am, Judge Dalene McIntyre - AKC Judge

Entries taken day of 7:00am-8:00am. Obedience entries will be restricted to the the number of runs that can be finished by 2pm, according to the calculations in the ASCA rule book (Ch 1 sec 21)

PRE-ENTRY DEADLINE: February 4, 2011 (postmarked)

Conformation-Altered/Intact: 6-9 month, 9-12 month, 12-18 month, Novice, American Bred, Bred By Exhibitor, Open Blue Merle, Open Red Merle, Open Black, Open Red, BOB

Entry fees: Regular conformation(altered/intact)/obedience: Pre-entry \$12.50, Day of show \$16.00

Non-regular conformation/obedience: \$8.00

Junior Handling: \$5.00

Ribbons to: BOBP, BOSP, Altered/Intact WD, RWD, WB, RWB, BOW, BOS, BOB, BJH, RJH, HITA, HITO, HITJr
Flats 1st through 4th place in class. This is "ribbons only" show.

Intact conformation will follow Altered. There will be no dryers/blowers or chalking in the arena. Stalls will be available for rent for \$10(no set up before Saturday AM), contact Margaret Cameron for reservations. Stall rentals will be donated to Rescue. All current ASCA Rules and regulations apply. All dogs 6 months of age or older must be registered with ASCA. Dogs not registered with ASCA must have an ASCA Tracking number (application available at show as a onetime fee) to compete in obedience. All entries must be on new official ASCA entry forms with the agreement on the back signed. All entry fees include \$1.00 per dog per class insurance fee. Incorrect and/or missing information will be the responsibility of the owner. Owners are responsible to clean up after their dogs and to keep their dogs in the show area only. Parents are responsible for their children. Exhibitors are responsible to clean up their grooming area of all garbage. People not cleaning up after themselves and their dogs may be asked to leave with no refund of entries. No sale of puppies/dogs on show grounds. A \$20.00 NSF charge will be applied on all returned checks.

From Tacoma and Seattle

• From I5 take the Old Nisqually exit 116 and get on Old Pacific Hwy until it ends • Turn LEFT onto Hwy 510
• in 1/2 mile turn RIGHT onto Meridian and follow it to the stop sign at Yelm Hwy • Continue straight ahead south on Meridian through a left turn and a right turn • When you see the 20 mph left turn sign turn LEFT onto Evergreen Valley Rd • It is less than 1/2 mile on your RIGHT.

From Portland

• Take exit 101 from I5 • Go east (right) on Tumwater Blvd. Stay on it until it ends. • Turn left onto Henderson Blvd • At the stop light turn right onto Yelm Highway -- follow it east about 7 miles • At the 76 station turn RIGHT onto Meridian and follow it south through a left turn and a right turn • When you see the 20 mph left turn sign turn LEFT onto Evergreen Valley Rd • It is less than 1/2 mile on your RIGHT
