Flats 1st through 4th place in class. This is "ribbons only" show.

Intact conformation will follow Altered. There will be no x-pens, dryers/blowers or chalking in the building. All current ASCA Rules and regulations apply. All dogs 6 months of age or older must be registered with ASCA. Dogs not registered with ASCA must have an ASCA Tracking number (application available at show as a one time fee) to compete in obedience. All entries must be on new official ASCA entry forms with the agreement on the back signed. All entry fees include \$1.00 per dog per class insurance fee. Incorrect and/or missing information will be the responsibility of the owner. Owners are responsible to clean up after their dogs and to keep their dogs in the show area only. Parents are responsible for their children. Exhibitors are responsible to clean up their grooming area of all garbage. People not cleaning up after themselves and their dogs may be asked to leave with no refund of entries. No sale of puppies/dogs on show grounds. A \$20.00 NSF charge will be applied on all returned checks.
